**NARRATIVE: ON WEDNESDAY, DECEMBER 30, 2015, MEMBERS OF THE WINNEBAGO COUNTY TAC UNIT AND ROCKFORD POLICE DEPARTMENT M3 TEAM CONDUCTED A PROSTITUTION STING AT A HOTEL IN ROCKFORD UTILIZING UNDERCOVER FEMALE OFFICERS.
