WINNEBAGO COUNTY SHERIFF GARY CARUANA IS PLEASED TO ANNOUNCE THE SHERIFF'S DEPARTMENT HAS REACHED AN AGREEMENT WITH THE UNITED STATES MARSHALS SERVICE (PRISONER OPERATIONS DIVISION) TO HOUSE FEDERAL INMATES IN THE WINNEBAGO COUNTY JAIL ON AN AS NEEDED BASIS. THE AGREEMENT TO HOUSE FEDERAL INMATES IN THE COUNTY JAIL WAS ONE OF SHERIFF CARUANA'S PRIORITIES UPON TAKING OFFICE IN DECEMBER OF 2014. THE SHERIFF CALLS THE AGREEMENT A WIN-WIN FOR THE SHERIFF'S DEPARTMENT AND THE FEDERAL GOVERNMENT. SHERIFF CARUANA NOTES THE REVENUE GENERATED BY THE AGREEMENT WILL HELP DEFRAY COSTS TO THE TAXPAYERS WHILE ENHANCING LAW ENFORCEMENT SERVICES IN WINNEBAGO COUNTY. SHERIFF CARUANA ALSO NOTES HOUSING FEDERAL INMATES IN THE WINNEBAGO COUNTY JAIL WILL REDUCE TRANSPORTATION COSTS FOR THE FEDERAL GOVERNMENT GIVEN THE JAIL'S CLOSE PROXIMITY TO THE FEDERAL COURTHOUSE IN DOWNTOWN ROCKFORD. THE AGREEMENT BETWEEN THE SHERIFF'S DEPARTMENT AND THE U.S MARSHALLS SERVICE IS EFFECTIVE IMMEDIATELY.
