**ON WEDNESDAY, JANUARY 27, 2016, THE WINNEBAGO COUNTY SHERIFF'S POLICE CONDUCTED A SATURATION PATROL WITH THE ASSISTANCE OF THE ROCKFORD POLICE DEPARTMENT, ILLINOIS STATE POLICE (DISTRICTS 15 & 16), LOVES PARK POLICE, SOUTH BELOIT POLICE, VILLAGE OF WINNEBAGO POLICE, ROCKFORD PARK DISTRICT POLICE, ROCK VALLEY COLLEGE POLICE AND THE DEPARTMENT OF HOMELAND SECURITY.**

**THE DETAIL WAS CONDUCTED IN THE CITY OF ROCKFORD IN "HOT SPOT" CRIME AREAS. OFFICERS FROM THE AGENCIES MADE 102 TRAFFIC STOPS, ISSUED 61 WRITTEN WARNINGS AND 42 CITATIONS, SERVED 16 ARREST WARRANTS, MADE 12 CRIMINAL ARRESTS, SEIZED 2 VEHICLES AND \$748.00 AND RECOVERED 2 HANDGUNS (1 OF WHICH WAS STOLEN), 10.9 GRAMS OF COCAINE, 87.6 GRAMS OF CANNABIS AND ONE STOLEN VEHICLE. K9'S FROM WINNEBAGO COUNTY, LOVES PARK, AND ISP WERE UTILIZED IN 11 SEARCHES.**

**AMONG THE CRIMINAL ARRESTS, THE FOLLOWING PERSONS WERE LODGED IN THE WINNEBAGO COUNTY JAIL:**

**-PATRICK L. TAYLOR (4/22/83) OF ROCKFORD- AGGRAVATED ASSAULT, AGGRAVATED BATTERY TO POLICE OFFICER, AGGRAVATED FLEEING TO ELUDE, POSSESSION OF CANNABIS (2.5-10G), DRIVING WHILE LICENSE REVOKED, AND RESISTING ARREST.**

**-DERRICK D. GULLEY (10/24/96) OF ROCKFORD- AGGRAVATED FLEEING TO ELUDE, NO VALID DRIVER'S LICENSE, VARIOUS OTHER TRAFFIC OFFENSES.**

**-FREDERICK L. MOSBY (3/17/95) OF ROCKFORD- ILLEGAL POSSESSION OF AMMUNITION, VARIOUS TRAFFIC OFFENSES.**

**-EARNEST L. HARRIS (11/6/64) OF ROCKFORD- POSSESSION OF CANNABIS (2.5- 10 G), POSSESSION OF COCAINE (> 1G), DRIVING WHILE LICENSE SUSPENDED, ROCKFORD WARRANT.**

**-DAMARCUS D. BELCHER (4/10/95) OF ROCKFORD- RESISTING ARREST.**
