ON FRIDAY, JANUARY 29TH, THE WINNEBAGO COUNTY SHERIFF'S DEPARTMENT'S NARCOTICS UNIT EXECUTED A SEARCH WARRANT AT 2507 WEST STATE STREET, ROCKFORD. THE NARCOTICS UNIT ARRESTED TWO PERSONS AND RECOVERED 18 INDIVIDUALLY WRAPPED PACKAGES WEIGHING TWO GRAMS.

CAPRISHA L. HART (3/6/87) OF ROCKFORD- POSSESSION WITH INTENT TO DELIVER HEROIN 1-15 G.

THE CHARGES AGAINST THOMPSON AND HART ARE MERELY ACCUSATIONS. THEY ARE PRESUMED INNOCENT UNLESS PROVEN GUILTY IN COURT.
