ON SATURDAY, JANUARY 30TH AT 0205 HOURS, THE WINNEBAGO COUNTY SHERIFF'S DEPARTMENT WAS DISPATCHED TO 1305 CARBAUGH AVENUE IN UNINCORPORATED ROCKFORD FOR A HOME INVASION.

ON SCENE, DEPUTIES DISCOVERED TWO FEMALES WITH GUNSHOT WOUNDS. BOTH WERE TRANSPORTED TO ROCKFORD MEMORIAL HOSPITAL. INVESTIGATION REVEALED THAT UNKNOWN PERSONS (S) FORCED ENTRY INTO THE HOME AND SHOT THE TWO WOMEN.

ONE OF THE FEMALES WAS PRONOUNCED DECEASED AT THE HOSPITAL. SHE WAS IDENTIFIED AS TREESA WILEY (35) OF ROCKFORD. THE SECOND VICTIM IS A 30 YEAR OLD FEMALE WHO IS IN STABLE CONDITION, RECOVERING FROM NON-LIFE THREATENING GUNSHOT WOUNDS.
