ON TUESDAY, FEBRUARY 9, 2016, THE WINNEBAGO COUNTY NARCOTICS UNIT EXECUTED A SEARCH WARRANT AT 443 UNDERWOOD STREET, ROCKFORD. MEMBERS OF THE UNIT RECOVERED 1.4 G OF HEROIN, 3.4 G OF COCAINE IN 24 INDIVIDUAL PACKAGES, .6 G OF CANNABIS, HYDROCODONE AND MORPHINE PILLS.

THE RESIDENT, IDENTIFIED AS RYAN SITTON (06/02/80) WAS LODGED & CHARGED WITH THE FOLLOWING OFFENSE:

- POSSESSION WITH INTENT TO DELIVER COCAINE (1-15G)
- POSSESSION WITH INTENT TO DELIVER HEROIN (1-15G)
- POSSESSION OF CANNABIS (LESS THAN 2.5G)
- POSSESSION OF A CONTROLLED SUBSTANCE
- RESISTING ARREST

THE CHARGES AGAINST SITTON ARE MERELY ACCUSATIONS AND HE IS PRESUMED INNOCENT UNTIL PROVEN GUILTY IN A COURT OF LAW.
