ON WEDNESDAY, FEBRUARY 17, 2016, THE WINNEBAGO COUNTY SHERIFF'S POLICE WERE JOINED BY THE ILLINOIS STATE POLICE (DISTRICTS 1,15, &16), ROCKFORD PD, VILLAGE OF WINNEBAGO PD, LOVES PARK PD, ROCK VALLEY COLLEGE PD, AND ROCKFORD PARK DISTRICT PD IN A SATURATION PATROL, TARGETING HIGH CRIME AREAS WITHIN THE CITY OF ROCKFORD.

DURING THE DETAIL, THE AGENCIES INVOLVED MADE 111 TRAFFIC STOPS, ISSUED 71 WRITTEN WARNINGS AND 71 TRAFFIC CITATIONS, ARRESTED 5 PERSONS ON WARRANTS AND MADE 31 CRIMINAL ARRESTS. POLICE ALSO RECOVERED 1 STOLEN VEHICLE, 3.7 G OF COCAINE, 6.9 G OF CANNABIS AND 41 PILLS OF VARIOUS CONTROLLED SUBSTANCES. 4 VEHICLES AND \$2,632.00 WERE SEIZED AS PART OF THE DETAIL.
