ON TUESDAY, MARCH 8, 2016, THE WINNEBAGO COUNTY SHERIFF'S DEPARTMENT NARCOTICS UNIT MADE AN ARREST IN A NARCOTICS INVESTIGATION. THE UNIT MADE AN ARREST IN AN UNDERCOVER DRUG BUY IN A PARKING LOT AT SOUTH ALPINE ROAD AND HARRISON AVENUE. THIS LED TO A SEARCH AT A RESIDENCE AT 4124 BEACH STREET IN ROCKFORD. THE UNIT RECOVERED 504 GRAMS OF HEROIN, 405 GRAMS OF CRACK COCAINE AND A .40 CALIBER HANDGUN. THE UNIT SEIZED TWO VEHICLES AND A LARGE AMOUNT OF CURRENCY. ARRESTED WAS MONTEL L. GLOVER (D.O.B. 5/13/91) WHO WAS WANTED ON A ROCKFORD PD WARRANT (\$200,000.00) FOR A PRIOR NARCOTICS INCIDENT. GLOVER WAS LODGED ON THE FOLLOWING CHARGES:

- POSSESSION WITH INTENT TO DELIVER HEROIN 400-900 G
- POSSESSION WITH INTENT TO DELIVER COCAINE 100-400 G
- POSSESSION WITH INTENT TO DELIVER HEROIN 15-100 G
- POSSESSION WITH INTENT TO DELIVER COCAINE 1-15 G
- UNLAWFUL USE OF A WEAPON BY A FELON
- DELIVERY OF HEROIN > 1 G
- RESISTING ARREST
- ROCKFORD PD WARRANT (\$200,000)- DELIVERY OF A CONTROLLED SUBSTANCE (HEROIN)

THE CHARGES AGAINST GLOVER ARE MERELY ACCUSATIONS AND HE IS PRESUMED INNOCENT UNTIL PROVEN GUILTY IN A COURT OF LAW.
