ON THURSDAY, MARCH 10, 2016, THE WINNEBAGO COUNTY SHERIFF'S TAC UNIT CONDUCTED SURVEILLANCE ON A KNOWN BURGLARY SUSPECT. FROM THE SURVEILLANCE, THE TAC UNIT CONDUCTED A TRAFFIC STOP ON THE SUSPECT AND ARRESTED HIM FOR A TRAFFIC VIOLATION. FROM THIS CONTACT WINNEBAGO COUNTY DETECTIVES WERE CALLED IN TO CONTINUE THE INVESTIGATION AND, FROM INTERVIEWS AND SEARCHING HIS VEHICLE AND THE LOCATIONS THE SUSPECT HAD BEEN, IT WAS DETERMINED BY THE TAC UNIT THAT THE SUSPECT HAD BURGLARIZED A STORAGE SHED AT 4902 STENSTROM ROAD IN ROCKFORD. DETECTIVES WERE ABLE TO CLEAR FOUR OTHER BURGLARIES AND THE TAC UNIT RECOVERED OVER \$10,000.00 IN STOLEN PROPERTY. THE FOLLOWING INDIVIDUAL WAS ARRESTED AND CHARGED:

-SCOTT B. BURTON (D.O.B. 7/3/64) OF ROCKFORD – BURGLARY, POSSESSION OF STOLEN PROPERTY AND DRIVING WHILE LICENSE SUSPENDED.

THE CHARGES AGAINST BURTON ARE MERELY ACCUSATIONS AND HE IS PRESUMED INNOCENT UNTIL PROVEN GUILTY IN A COURT OF LAW.
