ON FRIDAY NIGHT, MARCH 25TH, 2016 AND SATURDAY MORNING, MARCH 26TH, 2016, THE WINNEBAGO COUNTY SHERIFF'S DEPARTMENT WAS JOINED BY THE ILLINOIS STATE POLICE, ROCKFORD POLICE, VILLAGE OF WINNEBAGO POLICE, LOVES PARK POLICE, AND THE DEPARTMENT OF HOMELAND SECURITY IN A SATURATION DETAIL THAT TARGETED HIGH CRIME AREAS WITHIN THE CITY OF ROCKFORD.

DURING THE DETAIL, THE AGENCIES INVOLVED MADE 107 TRAFFIC STOPS, ISSUED 48 CITATIONS AND 60 WRITTEN WARNINGS. THERE WERE 5 FLEEING TO ELUDE ARRESTS, 24 VEHICLES WERE SEARCHED AND THERE WERE 10 CANINE SEARCHES. THERE WERE 2 CONTROLLED SUBSTANCE ARRESTS AND 3 ARRESTS FOR CANNABIS. THERE WERE 2 ARRESTS FOR DRIVING WITH A SUSPENDED LICENSE AND 1 D.U.I. ARREST. 5 PEOPLE WERE ARRESTED FOR OUTSTANDING WARRANTS AND THERE WERE 9 MISCELLANEOUS ARRESTS. 3 NOTICES TO APPEAR WERE ISSUED.

IN ADDITION, 2 VEHICLES WERE SEIZED DURING THE DETAIL, \$2,000.00 IN CASH WAS RECOVERED AND 1 SHOTGUN WAS SEIZED.
