**ON MONDAY, APRIL 18, 2016, WINNEBAGO COUNTY SHERIFF'S DETECTIVES MADE AN ARREST IN A RESIDENTIAL BURGLARY INVESTIGATION. ON DECEMBER 26, 2015, WINNEBAGO COUNTY DEPUTIES TOOK REPORTS OF FOUR SEPARATE RESIDENTIAL BURGLARIES THAT OCCURRED IN THE GREAT OAKS APARTMENT COMPLEX, 4839 LINDEN ROAD, ROCKFORD. DETECTIVES IDENTIFIED A SUSPECT AND MADE AN ARREST IN THE CASES. THE FOLLOWING INDIVIDUAL WAS ARRESTED AND LODGED IN THE WINNEBAGO COUNTY JAIL:**

**-TYRONE T. CARTER (D.O.B. 11/28/84) OF 4883 LINDEN ROAD, ROCKFORD- RESIDENTIAL BURGLARY.**
