BETWEEN APRIL 8, 2016 AND APRIL 12, 2016, WINNEBAGO COUNTY SHERIFF'S DEPUTIES TOOK REPORTS OF TWO RESIDENTIAL BURGLARIES AND SEVERAL VEHICLE BURGLARIES THAT OCCURRED IN THE NORTHEAST PART OF UNINCORPORATED ROSCOE, IN RURAL WINNEBAGO COUNTY. SEVERAL REPORTS OF A SUSPICIOUS WHITE MALE IN THIS AREA WERE ALSO TAKEN DURING THAT TIME PERIOD.

ON APRIL 12, 2016, AN OFF DUTY SHERIFF'S LIEUTENANT OBSERVED A SUSPICIOUS WHITE MALE IN ROSCOE THAT MATCHED THE DESCRIPTION OF THE SUSPECTED BURGLAR. A PATROL DEPUTY LOCATED THIS INDIVIDUAL AND TURNED HIM OVER TO DETECTIVES FOR FOLLOW UP. UPON FURTHER INVESTIGATION AND INTERVIEWS OF THE INDIVIDUAL, DETECTIVES MADE AN ARREST AND RECOVERED \$2,500.00 IN STOLEN PROPERTY. THE ARREST CLEARED TWO RESIDENTIAL BURGLARIES AND NINE BURGLARY FROM VEHICLE INCIDENTS, ALL HAVING OCCURRED IN RURAL ROSCOE. THE FOLLOWING INDIVIDUAL WAS ARRESTED, CHARGED AND LODGED:

**-JOSHUA D. KRAYNIK (D.O.B. 2/18/92) OF 10863 KEOKUK ROAD, ROSCOE
-RESIDENTIAL BURGLARY**

THE CHARGES AGAINST KRAYNIK ARE MERELY ACCUSATIONS AND HE IS PRESUMED INNOCENT UNTIL PROVEN GUILTY IN A COURT OF LAW.
