ON THURSDAY, APRIL 21, 2016 MEMBERS OF THE WINNEBAGO COUNTY SHERIFF'S NARCOTICS UNIT EXECUTED A SEARCH WARRANT AT 1708 26TH STREET, ROCKFORD. THE NARCOTICS UNIT RECOVERED 23.4 GRAMS OF COCAINE, 1.1 POUNDS OF CANNABIS, 4.2 GRAMS OF VARIOUS NARCOTIC PILLS AND A .380 RUGER HANDGUN. THE NARCOTICS UNIT SEIZED TWO VEHICLES AND \$22,603.00 IN CURRENCY. THE FOLLOWING PERSONS WERE ARRESTED, CHARGED AND LODGED IN THE WINNEBAGO COUNTY JAIL AS PART OF THE INVESTIGATION:

- WILLIAM D. SPEARS (D.O.B. 4/13/58) OF 1708 26TH STREET, ROCKFORD**
 - ~POSSESSION WITH INTENT TO DELIVER COCAINE (15-100 G)**
 - ~AGGRAVATED UNLAWFUL USE OF WEAPON BY A FELON**
 - ~POSSESSION WITH INTENT TO DELIVER CANNABIS (300-500 G) 2 COUNTS**

- SARAH M. WOOLBRIGHT (D.O.B. 9/14/79) OF 1708 26TH STREET, ROCKFORD**
 - ~POSSESSION WITH INTENT TO DELIVER COCAINE (1-15 GRAMS)**
 - ~POSSESSION OF A CONTROLLED SUBSTANCE**

THE CHARGES AGAINST SPEARS AND WOOLBRIGHT ARE MERELY ACCUSATIONS AND THEY ARE PRESUMED INNOCENT UNTIL PROVEN GUILTY IN A COURT OF LAW.
