ON MONDAY, APRIL 25, 2016 MEMBERS OF THE WINNEBAGO COUNTY SHERIFF'S NARCOTIC UNIT EXECUTED A SEARCH WARRANT AT 816 TAFT ROAD, ROCKFORD. THE NARCOTICS UNIT RECOVERED 18.6 GRAMS OF COCAINE, ECSTASY PILLS, AND A .45 LLAMA HANDGUN. THE UNIT SEIZED \$301 AND A VEHICLE. THE FOLLOWING PERSONS WERE ARRESTED, CHARGED AND LODGED IN THE WINNEBAGO COUNTY JAIL AS PART OF THE INVESTIGATION:

- CANDICE M. FERGUSON (D.O.B. 3/10/81) OF 816 TAFT ROAD, ROCKFORD**
 - ~POSSESSION WITH INTENT TO DELIVER COCAINE (1-15G) WITHIN 1,000 FEET OF A SCHOOL**
 - ~VIOLATION OF CONTROLLED SUBSTANCE ACT (ECSTASY)**
- RODNEY G. NYSTROM (D.O.B. 12/29/67) OF 4357 BROOK DALE ROAD, ROCKFORD**
 - ~POSSESSION WITH INTENT TO DELIVER COCAINE (1-15 GRAMS) WITHIN 1,000 FEET OF A SCHOOL (2 COUNTS)**
 - ~ARMED VIOLENCE**

THE CHARGES AGAINST FERGUSON AND NYSTROM ARE MERELY ACCUSATIONS AND THEY ARE PRESUMED INNOCENT UNTIL PROVEN GUILTY IN A COURT OF LAW.
