ON THURSDAY, APRIL 28, 2016 MEMBERS OF THE WINNEBAGO COUNTY SHERIFF'S NARCOTICS UNIT EXECUTED A SEARCH WARRANT AT 308 NORTH HORACE AVENUE IN ROCKFORD. THE NARCOTICS UNIT RECOVERED 7.4 GRAMS OF HEROIN AND 46.4 GRAMS OF COCAINE. THE UNIT SEIZED \$4,242.00 AND A VEHICLE. THE FOLLOWING PERSON WAS ARRESTED, CHARGED AND LODGED IN THE WINNEBAGO COUNTY JAIL AS PART OF THE INVESTIGATION:

-CHARLES E. ROBINSON (D.O.B. 3/13/80) OF 308 NORTH HORACE AVENUE, ROCKFORD
 ~POSSESSION W/INTENT TO DELIVER COCAINE (15-100G) WITHIN 1000 FEET OF A CHURCH
 ~POSSESSION W/INTENT TO DELIVER HEROIN (1-15G) WITHIN 1000 FEET OF A CHURCH.

THE CHARGES AGAINST ROBINSON ARE MERELY ACCUSATIONS AND HE IS PRESUMED INNOCENT UNTIL PROVEN GUILTY IN A COURT OF LAW.
