ON MONDAY, MAY 2, 2016, THE WINNEBAGO COUNTY SHERIFF'S NARCOTICS UNIT MADE TWO ARRESTS STEMMING FROM AN ONGOING INVESTIGATION. THE UNIT RECOVERED 52 GRAMS OF HEROIN, 57 GRAMS OF COCAINE, AND 6.4 GRAMS OF METHAMPHETAMINE. THE UNIT SEIZED TWO VEHICLES AND \$18,696.00. THE UNIT ARRESTED, CHARGED, AND LODGED THE FOLLOWING PERSONS IN THE WINNEBAGO COUNTY JAIL:

- JOSE F. SERRANO (11/10/90) OF 1410 SAWYER ROAD, ROCKFORD.
  - ~POSSESSION WITH INTENT TO DELIVER HEROIN (15-100 GRAMS)
  - ~POSSESSION WITH INTENT TO DELIVER COCAINE (15-100 GRAMS) 2 COUNTS
  - ~POSSESSION OF A CONTROLLED SUBSTANCE (METHAMPHETAMINES)
  
- JOSE R. RAMIREZ (7/11/81) OF 418 UNDERWOOD STREET, ROCKFORD
  - ~POSSESSION WITH INTENT TO DELIVER HEROIN (15-100 GRAMS)
  - ~POSSESSION WITH INTENT TO DELIVER COCAINE (15-100 GRAMS)

THE CHARGES AGAINST SERRANO AND RAMIREZ ARE MERELY ACCUSATIONS AND THEY ARE PRESUMED INNOCENT UNTIL PROVEN GUILTY IN A COURT OF LAW.
