ON WEDNESDAY, JUNE 22, 2016, THE WINNEBAGO COUNTY NARCOTICS UNIT ARRESTED TWO SUBJECTS IN A NARCOTICS INVESTIGATION. THE UNIT RECOVERED 3.4 GRAMS OF HEROIN DURING THE ARREST AND SEIZED \$1,294.00. THE ARREST OCCURRED AFTER A DELIVERY OF HEROIN IN AN UNDERCOVER STING IN THE AREA OF HIGHCREST AND ALPINE ROADS. THE SUSPECTS DELIVERED HEROIN WITH TWO CHILDREN IN THE VEHICLE. DEPUTIES TOOK CUSTODY OF THE CHILDREN, AGES 4 AND 7, AND SUBSEQUENTLY RELEASED THEM TO FAMILY MEMBERS. THE FOLLOWING SUSPECTS WERE ARRESTED, CHARGED AND LODGED IN THE WINNEBAGO COUNTY JAIL:

~MARK S. HARRIS (10/16/86) OF ROCKFORD AND EBONEY ADAMS (8/25/87) OF ROCKFORD. BOTH ARE CHARGED WITH:

- POSSESSION WITH INTENT TO DELIVER HEROIN 1-15 GRAMS WITHIN 1000 FEET OF A SCHOOL.
- DELIVERY OF HEROIN > 1 GRAM WITHIN 1000 FEET OF A SCHOOL.
- ENDANGERING THE LIFE AND HEALTH OF A CHILD.

THE CHARGES AGAINST HARRIS AND ADAMS ARE MERELY ACCUSATIONS AND THEY ARE PRESUMED INNOCENT UNTIL PROVEN GUILTY IN A COURT OF LAW.
