ON SUNDAY, JUNE 26<sup>TH</sup>, 2016, THE WINNEBAGO COUNTY SHERIFF'S DEPARTMENT RECEIVED A REPORT OF A MISSING PERSON IDENTIFIED AS DANIEL L. PERRY (86 YEAR OLD BLACK MALE). MR. PERRY WAS LAST SEEN BY HIS FAMILY IN THE 200 BLOCK OF FISHER ROAD IN SOUTH BELOIT AT APPROXIMATELY 8:30 P.M. SATURDAY, JUNE 25<sup>TH</sup>. IT'S BELIEVED HE WALKED AWAY FROM THIS LOCATION. DANIEL PERRY SUFFERS FROM DEMENTIA AND IS KNOWN TO WALK ALONG SHIRLAND AVENUE IN SOUTH BELOIT. DANIEL PERRY IS 5'8, 180 POUNDS AND HAS BLACK HAIR, A BEARD AND MUSTACHE. HE WAS WEARING A BLACK FEDORA AND A GREY SUIT. DANIEL PERRY WENT MISSING IN MARCH AND WAS FOUND IN THE 8500 BLOCK OF MONTAGUE ROAD IN RURAL WINNEBAGO.
