ON THURSDAY, JUNE 30, 2016, THE WINNEBAGO COUNTY SHERIFF'S NARCOTICS UNIT, ALONG WITH THE BELVIDERE/BOONE COUNTY METRO NARCOTICS UNIT, EXECUTED A SEARCH WARRANT AT 709 KENT STREET IN ROCKFORD. THE UNITS RECOVERED 32 GRAMS OF HEROIN AND .9 GRAMS OF CANNABIS. THE UNITS SEIZED \$1,641.00 AND A VEHICLE. THE UNITS ARRESTED, CHARGED AND LODGED THE FOLLOWING PERSON IN THE WINNEBAGO COUNTY JAIL:

~KAWACKI C. KELLER (11/10/74) OF ROCKFORD IS CHARGED WITH:

-POSSESSION WITH INTENT TO DELIVER HEROIN 15-100 GRAMS.

THE CHARGES AGAINST KELLER ARE MERELY ACCUSATIONS AND HE IS PRESUMED INNOCENT UNTIL PROVEN GUILTY IN A COURT OF LAW.
