ON WEDNESDAY, JULY 6, 2016 AT 12:41 A.M., A WINNEBAGO COUNTY SHERIFF'S DEPUTY INITIATED A TRAFFIC STOP AT S. PIERPONT AVENUE, JUST SOUTH OF HUDSON STREET ON A GRAY 2015 DODGE CHARGER WITH A TENNESSEE REGISTRATION WHICH RETURNED TO A RENTAL COMPANY. THE DRIVER OF THE VEHICLE REFUSED TO STOP. A PURSUIT WAS INITIATED AND THE DRIVER OF THE SUSPECT VEHICLE ATTEMPTED TO DRIVE THROUGH A FIELD AT LIBERTY STREET AND CONCORD AVENUE, WHERE THE PURSUIT ENDED.

AFTER A SHORT FOOT PURSUIT AND A STRUGGLE WITH A DEPUTY, SUSPECT DERICK D. PATTERSON (DOB 06/22/1988) WAS TAKEN INTO CUSTODY. TWO HANDGUNS WERE RECOVERED. ONE OF THE GUNS HAD AN EXTENDED MAGAZINE. DERICK PATTERSON ALSO HAD AN ACTIVE UNITED STATES MARSHALS SERVICE WARRANT FOR HIS ARREST FOR A PROBATION VIOLATION ON A WEAPONS OFFENSE. DERICK D. PATTERSON IS A CONVICTED FELON AND IS A DOCUMENTED MEMBER OF THE GANGSTER DISCIPLES STREET GANG.

DERICK D. PATTERSON WAS LODGED IN THE WINNEBAGO COUNTY JAIL ON NUMEROUS CHARGES INCLUDING AGGRAVATED DUI, DRIVING WITH A SUSPENDED LICENSE, AGGRAVATED FLEEING TO ELUDE, 2 COUNTS OF AGGRAVATED UNLAWFUL USE OF A WEAPON BY A STREET GANG MEMBER AND NO VALID FIREARM OWNER IDENTIFICATION CARD.

THE CHARGES AGAINST DERICK D. PATTERSON ARE MERELY ACCUSATIONS AND HE IS PRESUMED INNOCENT UNTIL PROVEN GUILTY IN A COURT OF LAW.
