ON TUESDAY, JULY 12, 2016, THE WINNEBAGO COUNTY SHERIFF'S NARCOTICS UNIT EXECUTED A SEARCH WARRANT AT 2717 KNIGHT AVENUE IN ROCKFORD. THE UNIT RECOVERED 1562 GRAMS OF CANNABIS, 46 CANNABIS SATIVA PLANTS, A HANDGUN AND A SHOTGUN. THE UNIT ARRESTED, CHARGED AND LODGED THE FOLLOWING PERSON:

**LUAN DABECA (D.O.B. 9/25/85) OF 2717 KNIGHT AVENUE, ROCKFORD**

- ~UNLAWFUL USE OF A WEAPON BY A FELON
- ~ARMED VIOLENCE
- ~POSSESSION WITH INTENT TO DELIVER CANNABIS 500-2,000 G
- ~POSSESSION OF 20-50 CANNABIS SATIVA PLANTS

THE CHARGES AGAINST DABECA ARE MERELY ACCUSATIONS AND HE IS PRESUMED INNOCENT UNTIL PROVEN GUILTY IN A COURT OF LAW.
