BETWEEN JANUARY 22, 2016 AND JULY 20, 2016, THE WINNEBAGO COUNTY SHERIFF'S TAC UNIT AND DEPARTMENT OF HOMELAND SECURITY CONDUCTED FOUR SEPARATE STING OPERATIONS TARGETING JUVENILE SEX CRIMES. - ~NIDAL M. MIZYED (7/20/73) OF ROCKFORD-INVOLUNTARY SERVITUDE OF A MINOR; POSSESSION WITH INTENT TO DELIVER 30-500 GRAMS OF CANNABIS.
- ~CECIL E. BURTON (9/19/77) OF ST. CHARLES, IL-INVOLUNTARY SERVITUDE OF A MINOR.
- ~TODD J. KASSAL (11/7/72) OF VILLA PARK, IL-INVOLUNTARY SERVITUDE OF A MINOR.
- ~MARK E. RICHARDS III (1/7/94) OF ROCKFORD-INVOLUNTARY SERVITUDE OF A MINOR.
