ON TUESDAY, AUGUST 30, 2016, THE WINNEBAGO COUNTY NARCOTICS UNIT EXECUTED A SEARCH WARRANT AT 1518 10TH STREET, LOWER APARTMENT. THE UNIT DISCOVERED TWO INDIVIDUALS IN THE APARTMENT ALONG WITH EVIDENCE OF NARCOTICS SALES AND DISTRIBUTION. ONE OF THE INDIVIDUALS WAS WANTED ON AN OUTSTANDING ARREST WARRANT AND THE OTHER WAS ON PAROLE.

THE UNIT RECOVERED 86 GRAMS OF CRACK COCAINE AND 1.4 GRAMS OF HEROIN. THE UNIT SEIZED \$1,800.00 IN UNITED STATES CURRENCY. THE FOLLOWING INDIVIDUALS WERE ARRESTED, CHARGED AND LODGED IN THE WINNEBAGO COUNTY JAIL:

~SHANTA S. MANNING (D.O.B. 10/20/1990) OF ROCKFORD

- POSSESSION WITH INTENT TO DELIVER COCAINE 15-100 G WITHIN 1000 FEET OF A CHURCH.
- POSSESSION WITH INTENT TO DELIVER HEROIN < 15 G WITHIN 1000 FEET OF A CHURCH.
- OUTSTANDING WARRANT FOR PROBATION VIOLATION.

~CHRISTOPHER X. SALLIS (11/8/1985) OF ROCKFORD

- POSSESSION WITH INTENT TO DELIVER COCAINE 15-100 G WITHIN 1000 FEET OF A CHURCH.
- POSSESSION WITH INTENT TO DELIVER HEROIN < 15 G WITHIN 1000 FEET OF A CHURCH.

THE CHARGES AGAINST MANNING AND SALLIS ARE MERELY ACCUSATIONS AND THEY ARE PRESUMED INNOCENT UNTIL PROVEN GUILTY IN A COURT OF LAW.
