**ON SEPTEMBER 19, 2016, WINNEBAGO COUNTY SHERIFF'S NARCOTICS UNIT EXECUTED A NARCOTICS SEARCH WARRANT AT 736 COLONIAL DRIVE, MACHESNEY PARK. THE UNIT RECOVERED 18.9 GRAMS OF COCAINE, 20 GRAMS OF CANNABIS AND TWO CANNABIS SATIVA PLANTS, ALONG WITH .380 CALIBER HANDGUN ROUNDS. THE UNIT ARRESTED, CHARGED AND LODGED THE FOLLOWING PERSON IN THE WINNEBAGO COUNTY JAIL:**
