JUST A REMINDER THAT TESTING WILL BE CONDUCTED AT 8 A.M. THIS SATURDAY, NOVEMBER 5TH, 2016 FOR THE POSITION OF WINNEBAGO COUNTY CORRECTIONS OFFICER. TESTING WILL TAKE PLACE AT THE WINNEBAGO COUNTY CRIMINAL JUSTICE CENTER, 650 WEST STATE STREET, ROCKFORD. APPLICANTS SHOULD REPORT TO THE FRONT LOBBY OF THE BUILDING.

A PHYSICAL AGILITY TEST WILL BE GIVEN, MEANING APPLICANTS SHOULD DRESS ACCORDINGLY. APPLICANTS MUST PASS THE AGILITY TEST IN ORDER TO QUALIFY FOR THE WRITTEN TEST, WHICH WILL BE CONDUCTED IMMEDIATELY AFTERWARDS.

APPLICANTS MUST BE AT LEAST 21 YEARS OLD, BE A U.S. CITIZEN AND HAVE A HIGH SCHOOL DIPLOMA OR A G.E.D. A VALID DRIVER'S LICENSE OR PICTURE I.D. IS REQUIRED IN ORDER TO TEST.
