INFORMATION: RESIDENTIAL BURGLARY ARRESTS

ON MONDAY, OCTOBER 31ST, 2016 AT APPROXIMATELY 11:00 A.M., POLICE RECEIVED A REPORT OF A BURGLARY AT A RESIDENCE IN THE 6600 BLOCK OF SAFFORD ROAD. DEPUTIES AND DETECTIVES RESPONDED AND THE SUSPECT VEHICLE WITH TWO SUSPECTS WAS SPOTTED NEAR TIPPLE ROAD AND PRAIRIE ROAD. THE VEHICLE WAS STOPPED AND TWO SUSPECTS WERE TAKEN INTO CUSTODY. THE SUSPECTS WERE IDENTIFIED AS ANTONIO D. JOHNSON (29) FROM ROCKFORD AND DAQUINN M. WHITFIELD (30) FROM ROCKFORD. THEY ARE BOTH CHARGED WITH RESIDENTIAL BURGLARY IN THIS INCIDENT.

THERE HAVE BEEN SEVERAL OTHER DAY TIME RESIDENTIAL BURGLARIES THAT HAVE OCCURRED IN RURAL WINNEBAGO COUNTY WEST OF ROCKFORD IN ADDITION TO BURGLARIES IN THE RESIDENTIAL AREA NEAR HIGHCREST ROAD AND ALPINE ROAD. DETECTIVES ARE WORKING TO ESTABLISH A LINK BETWEEN THESE SUSPECTS AND THE SERIES OF RESIDENTIAL BURGLARIES THAT HAVE OCCURRED THE LAST TWO MONTHS. ANYONE WITH INFORMATION CONCERNING THESE RECENT BURGLARIES IS ADVISED TO CONTACT THE WINNEBAGO COUNTY SHERIFF'S DETECTIVE BUREAU AT 815-319-6400.

THE CHARGES AGAINST ANTONIO D. JOHNSON AND DAQUINN M. WHITFIELD ARE MERELY ACCUSATIONS. THEY ARE PRESUMED INNOCENT UNTIL THEY ARE FOUND GUILTY IN A COURT OF LAW.
