ON NOVEMBER 3RD, 2016, A VICTIM MADE A REPORT TO THE WINNEBAGO COUNTY SHERIFF'S POLICE OF A BURGLARY TO A BARN LOCATED IN THE 6000 BLOCK OF FOREST PRESERVE ROAD IN UNINCORPORATED ROCKTON. IT WAS REPORTED THAT SEVERAL ITEMS WERE MISSING FROM INSIDE A BARN AT THIS LOCATION. THE VICTIM TRACKED A LARGE PIECE OF FARM EQUIPMENT TO A LOCAL METAL RECYCLER. DEPUTIES DEVELOPED A SUSPECT AND VEHICLE DESCRIPTION THANKS TO INFORMATION PROVIDED BY THE VICTIM AND THE COOPERATION OF THE LOCAL METAL RECYCLER.

ON NOVEMBER 5TH, 2016, A DEPUTY ON PATROL IN THE SOUTH BELOIT AREA SPOTTED THE SUSPECT AND THE VEHICLE BELIEVED TO BE INVOLVED IN THIS INCIDENT. A TRAFFIC STOP WAS CONDUCTED AT THE INTERSECTION OF SHIRLAND AVENUE AND TOWNLIN AVENUE IN SOUTH BELOIT. THE SUSPECT, IDENTIFIED AS 53 YEAR OLD DELBERT MONROE, OF ROCKFORD, WAS TAKEN INTO CUSTODY AND CHARGED WITH BURGLARY.
