ON FRIDAY, NOVEMBER 25<sup>TH</sup> 2016 AT APPROXIMATELY 11:14 P.M., A WINNEBAGO COUNTY SHERIFF'S DEPUTY STOPPED A VEHICLE AT NORTH MAIN STREET & BAUER PARKWAY FOR TRAFFIC VIOLATIONS. SHERIFF'S POLICE WERE ASSISTED BY ILLINOIS STATE POLICE DISTRICT 16.

DURING THE INVESTIGATION, OFFICERS LOCATED OVER 30 GRAMS OF CANNABIS IN THE VEHICLE ALONG WITH OTHER DRUG PARAPHERNALIA AND UNITED STATES CURRENCY.

DEPUTIES ARRESTED 21 YEAR OLD LUIS G. HERNANDEZ-INUSTROZA OF LOVES PARK. HERNANDEZ-INUSTROZA WAS CHARGED WITH MANUFACTURE AND DELIVERY OF 30-500 GRAMS OF CANNABIS, POSSESSION OF DRUG PARAPHERNALIA AND SEVERAL TRAFFIC OFFENSES. HERNANDEZ-INUSTROZA WAS LODGED IN THE WINNEBAGO COUNTY JAIL WITH BOND SET AT \$7,500.00.

THE CHARGES AGAINST LUIS G. HERNANDEZ-INUSTROZA ARE MERELY ACCUSATIONS. HE IS PRESUMED INNOCENT UNTIL PROVEN GUILTY IN A COURT OF LAW.
