ON SUNDAY, NOVEMBER 27TH 2016 AT 8:53 P.M., WINNEBAGO COUNTY SHERIFF'S DEPUTIES STOPPED A VEHICLE AT THE INTERSECTION OF NORTH MAIN (ILLINOIS ROUTE 2) AND LATHAM ROAD FOR TRAFFIC VIOLATIONS.

DURING THE INVESTIGATION, SHERIFF'S DEPUTIES RECOVERED OVER 130 GRAMS OF SUSPECTED CANNABIS FROM THE VEHICLE ALONG WITH UNITED STATES CURRENCY.

55 YEAR OLD JAMES A. BERTRAND OF MACHESNEY PARK WAS TAKEN INTO CUSTODY ON THE FOLLOWING CHARGES:

- ~POSSESSION OF CANNABIS WITH INTENT TO DELIVER (2 COUNTS)**
- ~SPEEDING**

BERTRAND WAS LODGED IN THE WINNEBAGO COUNTY JAIL WITH BOND SET AT \$10,000.00.

THE CHARGES AGAINST JAMES A. BERTRAND ARE MERELY ACCUSATIONS. HE IS PRESUMED INNOCENT UNTIL PROVEN GUILTY IN A COURT OF LAW.
