THE WINNEBAGO COUNTY SHERIFF'S OFFICE CONDUCTED ENFORCEMENT FROM NOVEMBER 14-27, REMINDING MOTORISTS TO BUCKLE UP AND NOT DRIVE IMPAIRED, BOTH DAY AND NIGHT, DURING THE "CLICK IT OR TICKET" MOBILIZATION. THE WINNEBAGO COUNTY SHERIFF'S OFFICE JOINED OTHER STATE AND LOCAL LAW ENFORCEMENT AGENCIES ACROSS ILLINOIS TO REDUCE HIGHWAY FATALITIES BY CRACKING DOWN ON UNBUCKLED MOTORISTS AND IMPAIRED DRIVERS.
