ON FRIDAY, JANUARY 27, 2017, THE WINNEBAGO COUNTY SHERIFF'S DEPARTMENT TAC TEAM EXECUTED A SEARCH WARRANT AT 7081 LINDEN ROAD APARTMENT 1214, ROCKFORD. THE TAC TEAM TOOK TWO PERSONS INTO CUSTODY AND RECOVERED 20 GRAMS OF CRACK COCAINE, 5.6 GRAMS OF HEROIN AND TWO HANDGUNS: A SMITH & WESSON .22 CALIBER AND A HI-POINT .45 CALIBER, WHICH WAS STOLEN OUT OF MACHESNEY PARK. THE FOLLOWING INDIVIDUALS WERE ARRESTED, CHARGED AND LODGED IN THE WINNEBAGO COUNTY JAIL:

- POSSESSION WITH INTENT TO DELIVER HEROIN 1-15 GRAMS

~NATOSHA L. GLASS (2/18/93) OF ROCKFORD

- ARMED VIOLENCE
- POSSESSION OF A STOLEN FIREARM
- POSSESSION WITH INTENT TO DELIVER COCAINE 15-100 GRAMS
- POSSESSION WITH INTENT TO DELIVER HEROIN 1-15 GRAMS.

THE CHARGES AGAINST DERRICK T. NEVILLE AND NATOSHA L. GLASS ARE MERELY ACCUSATIONS. THEY ARE PRESUMED INNOCENT UNTIL PROVEN GUILTY IN A COURT OF LAW.
