**ON WEDNESDAY, FEBRUARY 1, 2017, THE WINNEBAGO COUNTY SHERIFF'S DEPARTMENT NARCOTICS UNIT AND TAC TEAM WERE CONDUCTING SURVEILLANCE OF DRUG SALES OCCURRING IN THE 3100 BLOCK OF 11<sup>TH</sup> STREET. THE DEPUTIES ATTEMPTED TO MAKE AN ARREST AND TWO SUSPECTS FLED ON FOOT. ONE OF THE SUSPECTS WAS CAPTURED AND THE SECOND WAS NOT LOCATED. DEPUTIES IDENTIFIED THE SECOND SUSPECT AND WILL OBTAIN A WARRANT AT A LATER DATE. THE DEPUTIES RECOVERED 1.8 GRAMS OF HEROIN, 3 GRAMS OF CRACK COCAINE AND 2 STOLEN 9 MM HANDGUNS. ONE GUN WAS STOLEN OUT OF MACHESNEY PARK AND THE OTHER OUT OF TWIN FALLS, ID. THE FOLLOWING INDIVIDUAL WAS ARRESTED, CHARGED AND LODGED IN THE WINNEBAGO COUNTY JAIL:**

- ~KEON K. WINFORD (4/1/93) OF ROCKFORD**
- AGGRAVATED UNLAWFUL USE OF A WEAPON BY A FELON.**
- POSSESSION OF A STOLEN FIREARM.**

**THE CHARGES AGAINST WINFORD ARE MERELY ACCUSATIONS AND HE IS PRESUMED INNOCENT UNTIL PROVEN GUILTY IN A COURT OF LAW.**
