ON TUESDAY, FEBRUARY 14, 2017, THE WINNEBAGO COUNTY SHERIFF'S DEPARTMENT NARCOTICS UNIT WAS CONDUCTING SURVEILLANCE OF DRUG SALES OCCURRING IN THE 3100 BLOCK OF 11TH STREET. THE DEPUTIES OBSERVED A SUSPECT SELLING NARCOTICS. DURING THE SURVEILLANCE, DEPUTIES OBSERVED THE SAME SUSPECT BEATING TWO PUPPIES IN THE BACK SEAT OF HIS CAR. AS DEPUTIES ATTEMPTED TO ARREST THE SUSPECT, HE FLED ON FOOT. DEPUTIES ARRESTED THE SUSPECT AFTER A BRIEF FOOT CHASE AND STRUGGLE. DEPUTIES RECOVERED 7 GRAMS OF CRACK COCAINE, .4 GRAMS OF HEROIN AND \$1,466.00 IN CASH. WINNEBAGO COUNTY ANIMAL SERVICES TOOK CUSTODY OF THE PUPPIES. THE FOLLOWING INDIVIDUAL WAS ARRESTED, CHARGED AND LODGED IN THE WINNEBAGO COUNTY JAIL:

- UNLAWFUL DELIVERY OF LESS THAN ONE GRAM OF HEROIN WITHIN 1,000 FEET OF A CHURCH.
- POSSESSION WITH INTENT TO DELIVER COCAINE 1-15 GRAMS WITHIN 1,000 FEET OF A SCHOOL.
- CRUELTY TO ANIMALS
- RESISTING ARREST.

THE CHARGES AGAINST ANDERSON ARE MERELY ACCUSATIONS AND HE IS PRESUMED INNOCENT UNTIL PROVEN GUILTY IN A COURT OF LAW.
