ON FRIDAY, APRIL 14, 2017 AND SATURDAY APRIL 15, 2017, THE WINNEBAGO COUNTY SHERIFF'S DEPARTMENT TEAMED UP WITH THE ROCKFORD POLICE DEPARTMENT, ILLINOIS STATE POLICE, LOVES PARK POLICE, SOUTH BELOIT POLICE, VILLAGE OF WINNEBAGO POLICE, ROCK VALLEY COLLEGE POLICE AND THE DEPARTMENT OF HOMELAND SECURITY TO CONDUCT SATURATION PATROLS IN HIGH CRIME AREAS WITHIN THE CITY OF ROCKFORD.

THE RESULTS OF THE TWO NIGHT DETAIL INCLUDE:

- ~153 TRAFFIC STOPS
- ~59 CITATIONS
- ~62 WRITTEN WARNINGS
- ~18 ARRESTS FOR DRIVING AFTER SUSPENSION/REVOICATION
- ~15 CRIMINAL WARRANTS SERVED
- ~3 HANDGUNS RECOVERED, ONE OF WHICH WAS STOLEN
- ~1 STOLEN VEHICLE RECOVERED
- ~79 GRAMS OF CANNABIS RECOVERED
- ~9 GRAMS OF COCAINE RECOVERED
- ~1 DRIVING UNDER THE INFLUENCE ARREST

THE FOLLOWING INDIVIDUALS WERE ARRESTED BY DEPUTIES AND LODGED IN THE WINNEBAGO COUNTY JAIL:

~KENNETH K. GADDIE (6/2/89) OF ROCKFORD FOR AGGRAVATED FLEEING TO ELUDE, 2 WINNEBAGO COUNTY FAILURE TO APPEAR WARRANTS & 1 ROCKFORD FAILURE TO APPEAR WARRANT.

~MARTAVIES J. BLAKE (12/27/96) OF ROCKFORD FOR POSSESSION WITH INTENT TO DELIVER CANNABIS (LESS THAN 10 GRAMS)

~DOMINIQUE E. SHOALS (7/17/91) OF ROCKFORD FOR POSSESSION WITH INTENT TO DELIVER COCAINE (1-15 GRAMS) & DRIVING WHILE LICENSE REVOKED.

THE CHARGES AGAINST GADDIE, BLAKE AND SHOALS ARE MERELY ACCUSATIONS AND THEY ARE PRESUMED INNOCENT UNTIL PROVEN GUILTY IN A COURT OF LAW.
