INFORMATION: THREE PEOPLE ARRESTED FOR DRUGS AND WEAPONS CHARGES

ON THURSDAY, APRIL 27, 2017, THE WINNEBAGO COUNTY SHERIFF'S NARCOTICS UNIT AND SWAT TEAM EXECUTED TWO SEPARATE SEARCH WARRANTS. THE SEARCH WARRANTS WERE EXECUTED AT 2955 LAPEY STREET AND 210 MIRIAM AVENUE.

FROM 2955 LAPEY STREET, DEPUTIES RECOVERED A RIFLE, TWO SHOTGUNS AND FOUR HANDGUNS, ONE OF WHICH WAS FOUND TO BE STOLEN OUT OF WINNEBAGO COUNTY. DEPUTIES RECOVERED 5.5 GRAMS OF COCAINE, 3.7 GRAMS OF PSILOCYBIN MUSHROOMS, AND 70 GRAMS OF CANNABIS. THE FOLLOWING PERSONS WERE ARRESTED BY DEPUTIES AND LODGED IN THE WINNEBAGO COUNTY JAIL:

~DAVID A. BENNETT SR. (4/29/61) OF ROCKFORD FOR POSSESSION OF A STOLEN HANDGUN & REVOKED FOID.

~DAVID A. BENNETT JR. (5/2/95) OF ROCKFORD FOR POSSESSION WITH INTENT TO DELIVER COCAINE (1-15 GRAMS), POSSESSION WITH INTENT TO DELIVER PSILOCYBIN MUSHROOMS (1-15 GRAMS) AND POSSESSION WITH INTENT TO DELIVER CANNABIS (30-500 GRAMS)

FROM 210 MIRIAM AVENUE, DEPUTIES RECOVERED TWO HANDGUNS, 17.4 GRAMS OF COCAINE AND 1.8 GRAMS OF HEROIN. THE FOLLOWING PERSON WAS ARRESTED BY DEPUTIES AND LODGED IN THE WINNEBAGO COUNTY JAIL:

~ALONTE M. BJORLIE (4/5/96) OF ROCKFORD FOR POSSESSION WITH INTENT TO DELIVER COCAINE (15-100 GRAMS), POSSESSION WITH INTENT TO DELIVER HEROIN (1-15 GRAMS) WITHIN 1000 FEET OF A SCHOOL & NO FOID.

THE CHARGES AGAINST BENNETT, BENNETT AND BJORLIE ARE MERELY ACCUSATIONS AND THEY ARE PRESUMED INNOCENT UNTIL PROVEN GUILTY IN A COURT OF LAW.
