**ON MONDAY, MAY 8<sup>TH</sup>, 2017 AT 0313 HOURS, WINNEBAGO COUNTY SHERIFF'S DEPUTIES RESPONDED TO 8700 GROVE HILL ROAD FOR A REPORT OF A VEHICLE BREAK-IN. TWO VEHICLES WERE ENTERED AT A RESIDENCE HERE AFTER A WINDOW WAS SMASHED ON EACH. A PURSE WAS TAKEN FROM ONE OF THE VEHICLES.**

**WHILE ON SCENE, THE INVESTIGATING DEPUTY SAW A SUSPICIOUS VEHICLE DRIVING THROUGH THE SUB-DIVISION. THE DEPUTY WAS ABLE TO STOP THE VEHICLE WITH THREE OCCUPANTS AND DISCOVERED PROPERTY THAT WAS STOLEN IN THE BREAK-INS ON GROVE HILL ROAD.**

**WINNEBAGO COUNTY SHERIFF'S DETECTIVES ASSISTED IN THE INVESTIGATION. DETECTIVES ARE PURSUING LEADS TO ESTABLISH LINKS TO OTHER VEHICLE BURGLARIES THAT HAVE OCCURRED.**
