ON MONDAY, JUNE 12, 2017, WINNEBAGO COUNTY SHERIFF'S NARCOTICS OFFICERS WERE CONDUCTING SURVEILLANCE IN THE AREA OF THE 500 BLOCK OF 7TH STREET WHEN A NARCOTICS TRANSACTION WAS OBSERVED BETWEEN INDIVIDUALS.

NARCOTICS OFFICERS STOPPED THE SUSPECT VEHICLE DELIVERING NARCOTICS AND MADE CONTACT WITH THE OCCUPANT OF THE VEHICLE WHO WAS FOUND TO BE IN POSSESSION OF 39.4 GRAMS OF CRACK COCAINE AND \$1,500.00 CASH. THE FOLLOWING INDIVIDUAL WAS ARRESTED, CHARGED AND LODGED IN THE WINNEBAGO COUNTY JAIL:
