INFORMATION: LOVES PARK MAN ARRESTED ON DRUG & WEAPONS CHARGES FOLLOWING PURSUIT.

ON FRIDAY, JUNE 23, 2017 AT 12:55 A.M., A WINNEBAGO COUNTY SHERIFF'S DEPUTY ATTEMPTED TO STOP A 2005 CHEVY IMPALA FOR SPEEDING AT SCHOOL STREET AND DAY AVENUE. THE DRIVER ATTEMPTED TO FLEE, HOWEVER WINNEBAGO COUNTY SHERIFF'S TAC DEPUTIES DEPLOYED A TIRE FLATTENING DEVICE AT AUBURN STREET AND CENTRAL AVENUE SUCCESSFULLY DEFLATING ALL FOUR TIRES OF THE FLEEING VEHICLE. THE SUSPECT STOPPED IN THE 900 BLOCK OF ACORN STREET AND FLED ON FOOT. THE SUSPECT WAS CAPTURED AFTER A BRIEF FOOT PURSUIT.

THE SUSPECT WAS FOUND TO BE IN POSSESSION OF A .40 CALIBER HANDGUN, 12.5 GRAMS OF HEROIN, 28.7 GRAMS OF CRACK COCAINE, 62 GRAMS OF CANNABIS AND \$750 CASH. THE LISTED SUSPECTED WAS ARRESTED AND LODGED IN THE WINNEBAGO COUNTY JAIL, CHARGED WITH THE FOLLOWING:

- AGGRAVATED FLEEING TO ELUDE
- UNLAWFUL USE OF A WEAPON BY A FELON
- ARMED VIOLENCE
- POSSESSION WITH INTENT TO DELIVER COCAINE 15-100 GRAMS
- POSSESSION WITH INTENT TO DELIVER HEROIN 1-15 GRAMS
- POSSESSION WITH INTENT TO DELIVER CANNABIS 30-500 GRAMS
- SPEEDING
- ILLEGAL TRANSPORTATION OF ALCOHOL
- No FOID
