ON THURSDAY, JUNE 29, 2017, THE WINNEBAGO COUNTY NARCOTICS UNIT CONDUCTED A FOLLOW UP INVESTIGATION REGARDING INFORMATION OF A MARIJUANA GROW OPERATION IN THE 800 BLOCK OF TAYLOR STREET, IN THE VILLAGE OF PECATONICA.

THE INVESTIGATION LED NARCOTICS OFFICERS TO AN ADDRESS WHERE THEY LOCATED EVIDENCE OF A GROW OPERATION THAT HAD RECENTLY BEEN DISMANTLED. THE UNIT LOCATED THE OWNER OF THE PROPERTY, WHO WAS FOUND TO BE IN POSSESSION OF 2.5 POUNDS OF CANNABIS.

THE FOLLOWING PERSON WAS ARRESTED AND LODGED IN THE WINNEBAGO COUNTY JAIL CHARGED WITH THE FOLLOWING:

-POSSESSION OF CANNABIS (500-2,000 GRAMS)**

THE CHARGE AGAINST HECKMAN IS A MERE ACCUSATION AND HE IS PRESUMED INNOCENT UNTIL PROVEN GUILTY IN A COURT OF LAW.
