ON JUNE 30, 2017 AT APPROXIMATELY 10:35 A.M., DEPUTIES FROM THE WINNEBAGO COUNTY SHERIFF'S NARCOTICS UNIT ACTED UPON A TIP THAT A CANNABIS GROW OPERATION WAS BEING CONDUCTED AT A RESIDENCE AT 13600 BEAVER DRIVE IN UNINCORPORATED ROSCOE, IL. DURING THE INVESTIGATION, APPROXIMATELY 70 PLANTS AND 3700 GRAMS OF HARVESTED CANNABIS WERE LOCATED. TWO PICKUP TRUCKS AND A MOTORCYCLE WERE SEIZED.

**JOHN F. CARRATT (08/04/1953) OF SOUTH BELOIT, IL IS CHARGED WITH THE FOLLOWING:
-PRODUCTION OF 50-200 CANNABIS PLANTS
-MANUFACTURE/DELIVERY OF CANNABIS (2000-5000 GRAMS)**

CARRATT IS LODGED IN THE WINNEBAGO COUNTY JAIL IN LIEU OF BOND. THE CHARGES AGAINST CARRATT ARE MERELY ACCUSATIONS AND HE IS PRESUMED INNOCENT UNTIL PROVEN GUILTY IN A COURT OF LAW.
