ON 07/06/2017 SHERIFF GARY CARUANA AND SHERIFF'S DEPARTMENT PERSONNEL HAVE ASSESSED THE CURRENT RIVER CONDITIONS. AS OF 3:00 P.M ON THURSDAY, JULY 6TH, 2017 THE RIVER LEVELS CONTINUE TO DROP. SHERIFF CARUANA ANNOUNCES THE FOLLOWING RESTRICTIONS FOR THE ROCK RIVER BEGINNING AT 8:00 A.M FRIDAY, JULY 7TH, 2017:

THE "NO WAKE ZONE" ON THE ROCK RIVER FROM THE RIVERSIDE BRIDGE SOUTH TO THE FORDHAM DAM HAS BEEN CANCELLED. THE "NO WAKE ZONE" NORTH OF THE RIVERSIDE BRIDGE WILL STILL BE IN EFFECT UNTIL FURTHER NOTICE. THE RIVER CONDITIONS ARE BEING ASSESSED ON A DAILY BASIS
