SHERIFF GARY CARUANA HAS LIFTED THE NO WAKE ORDER FOR THE ROCK RIVER IN WINNEBAGO COUNTY EFFECTIVE IMMEDIATELY. THE SHERIFF'S OFFICE SAYS RIVER LEVELS DROPPED OVERNIGHT, PROMPTING THE SHERIFF TO RESCIND THE NO WAKE ORDER.
