ON JULY 13, 2017 AT 9:55 P.M., THE WINNEBAGO COUNTY SHERIFF'S DEPARTMENT WAS DISPATCHED TO ALPINE VETERINARY CLINIC, 4502 CHARLES STREET, FOR A REPORT OF CRIMINAL DAMAGE TO PROPERTY. A CLINIC EMPLOYEE OBSERVED WINDOWS BROKEN BY THROWN ROCKS. THIS WAS THE THIRD TIME SINCE MAY 20TH, 2017 THAT BROKEN WINDOWS WERE DISCOVERED AT THE CLINIC.

IMAGES WERE DEVELOPED OF A SUSPECT FROM VIDEO SURVEILLANCE CAPTURED ON JULY 13TH AND SHARED BY THE VICTIM THROUGH SOCIAL MEDIA. THE SHARED IMAGES GENERATED TIPS THAT WERE INVESTIGATED BY THE SHERIFF'S DEPARTMENT DETECTIVE BUREAU.

A JUVENILE SUSPECT (17 YEAR OLD MALE) WAS ARRESTED AT 5 P.M. JULY 17TH, 2017. HE WAS CHARGED WITH CRIMINAL DAMAGE TO PROPERTY (FELONY) FOR THE THREE INCIDENTS AND WAS PROCESSED AT THE JUVENILE ASSESSMENT CENTER. THE JUVENILE IS CONSIDERED INNOCENT UNLESS PROVEN GUILTY IN A COURT OF LAW.
