**THE WINNEBAGO COUNTY SHERIFF'S OFFICE WILL CONTINUE TO MONITOR RIVER LEVELS THIS WEEKEND WITH THE POTENTIAL FOR ADDITIONAL SIGNIFICANT RAINFALL OVER THE NEXT 72 HOURS. EARLIER TODAY, SHERIFF GARY CARUANA ISSUED A NO WAKE ORDER UNTIL FURTHER NOTICE FOR THE ROCK RIVER IN ALL OF WINNEBAGO COUNTY.**

**GIVEN THE SIGNIFICANT RAINS OF THE PAST FEW DAYS AND THE PROSPECT OF ADDITIONAL RAINFALL IN THE NEAR FUTURE...RIVER LEVELS IN THE AREA ARE EXPECTED TO CONTINUE TO RISE. HOWEVER, THE SHERIFF'S OFFICE EMPHASIZES THAT THERE ARE NO EVACUATION ORDERS IN EFFECT ANYWHERE IN WINNEBAGO COUNTY. THE SHERIFF'S OFFICE WILL INFORM THE PUBLIC AND THE LOCAL MEDIA SHOULD THAT CHANGE.**
