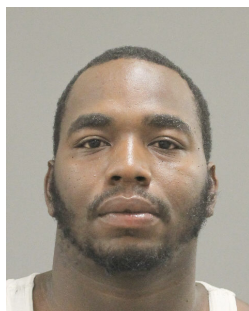

ON TUESDAY, JULY 25TH, 2017, AT APPROXIMATELY 9:30 A.M., WINNEBAGO COUNTY SHERIFF'S DETECTIVES EXECUTED A SEARCH WARRANT AT 1033 WOODLAWN AVENUE IN ROCKFORD. ONCE INSIDE, POLICE RECOVERED A STOLEN HANDGUN AND APPROXIMATELY 570 GRAMS OF SYNTHETIC CANNABIS. THE FOLLOWING INDIVIDUAL WAS ARRESTED AND LODGED IN THE WINNEBAGO COUNTY JAIL:
