ON TUESDAY, JULY 25<sup>TH</sup>, 2017 AT APPROXIMATELY 6:05 P.M., WINNEBAGO COUNTY SHERIFF'S DETECTIVES CONDUCTED A NARCOTICS INVESTIGATION AT 217 ROYAL AVENUE IN ROCKFORD. DETECTIVES RECOVERED APPROXIMATELY 200 GRAMS OF COCAINE AND APPROXIMATELY 1 POUND OF CANNABIS. THE FOLLOWING INDIVIDUAL WAS ARRESTED AND LODGED IN THE WINNEBAGO COUNTY JAIL:
