**THE ILLINOIS DEPARTMENT OF NATURAL RESOURCES HAS ANNOUNCED THE REOPENING OF THE ROCK RIVER IN WINNEBAGO COUNTY EFFECTIVE IMMEDIATELY. D-N-R OFFICIALS SAY RIVER LEVELS HAVE FALLEN SIGNIFICANTLY IN RECENT DAYS.**

**WINNEBAGO COUNTY SHERIFF GARY CARUANA SAYS A TEMPORARY NO WAKE ORDER WILL BE IN EFFECT ON THE ROCK RIVER IN WINNEBAGO COUNTY UNTIL FURTHER NOTICE. THE SHERIFF SAYS THE NO WAKE ORDER DESIGNATION WILL BE RE-EVALUATED ON MONDAY, AUGUST 7<sup>TH</sup>.**
