WINNEBAGO COUNTY SHERIFF GARY CARUANA SAYS THE "NO WAKE ZONE" ON THE ROCK RIVER FROM THE RIVERSIDE BRIDGE SOUTH TO FORDAM DAM WILL BE LIFTED EFFECTIVE AT 5 P.M., MONDAY, AUGUST 7TH, 2017. SHERIFF CARUANA SAYS THE "NO WAKE ZONE" ON THE ROCK RIVER NORTH OF THE RIVERSIDE BRIDGE REMAINS IN EFFECT UNTIL FURTHER NOTICE. RIVER CONDITIONS IN WINNEBAGO COUNTY ARE BEING ASSESSED ON A DAILY BASIS.
