WINNEBAGO COUNTY SHERIFF GARY CARUANA IS LIFTING THE NO WAKE ORDER FOR THE ENTIRE ROCK RIVER IN WINNEBAGO COUNTY EFFECTIVE IMMEDIATELY. SHERIFF CARUANA SAYS RIVER LEVELS HAVE DROPPED SIGNIFICANTLY IN RECENT DAYS FOLLOWING TORRENTIAL RAINFALL IN JULY.

THE SHERIFF'S DEPARTMENT WILL CONTINUE TO HAVE A PATROL PRESENCE ON THE ROCK RIVER. ANYONE WITH QUESTIONS ABOUT RIVER CONDITIONS CAN CONTACT THE SHERIFF'S DEPARTMENT RIVER PATROL AT (815) 262-1510.
