

ON SEPTEMBER 19, 2017 AT 11:59 P.M., A WINNEBAGO COUNTY SHERIFF'S DEPUTY ATTEMPTED TO STOP A VEHICLE TRAVELING AT A HIGH RATE OF SPEED NEAR THE INTERSECTION OF ANDREWS AND CENTRAL IN ROCKFORD. THE DRIVER OF THE SUSPECT VEHICLE REFUSED TO STOP. A SHORT TIME LATER, ANOTHER SHERIFF'S DEPUTY SPOTTED THE SUSPECT VEHICLE AT AUBURN AND DAY STREETS AND BEGAN A PURSUIT. THE DRIVER OF THE SUSPECT VEHICLE AGAIN REFUSED TO STOP AND DISREGARDED SEVERAL STOP SIGNS. THE SHERIFF'S DEPUTY LOST SIGHT OF THE SUSPECT VEHICLE AND TERMINATED THE PURSUIT. MINUTES LATER, THE SUSPECT VEHICLE WAS SPOTTED NEAR WEST STATE STREET AND MERIDIAN ROAD AND THEN HEADED NORTH ON SPRINGFIELD NEARLY COLLIDING WITH A SHERIFF'S DEPARTMENT VEHICLE. THE SUSPECT VEHICLE EVENTUALLY CRASHED INTO A UTILITY POLE NEAR KILBURN AND GLENWOOD. THE DRIVER OF THE SUSPECT VEHICLE FLED ON FOOT AND WAS CAPTURED.
